serving the community through various programs including Fatherhood services, Child Removal Preventive Services, Family Education, Eviction Prevention, and a Basic Needs Program. Over the course of almost 8 years with Catholic Charities, Tomas worked hard to help many families in the Waterbury community. His work did not go unnoticed, and he was promoted internally, receiving recognition and awards for his commitment to help the community.

Currently, Tomas serves the community through the Working Cities Challenge initiative, focused on removing barriers the Waterbury community, and particularly the South End community, faces towards finding sustainable employment. This initiative also focuses on systems change and promoting equitable access, with a focus to lower the unemployment rate in the South End neighborhood by 10% over a 10-year period.
