**James A. Higgins** is a Naugatuck resident and serves on the borough's finance board along with committees for special projects under Mayor Hess. He also participates in parent-teacher organizations at four of the Naugatuck Public Schools. James has dedicated his life to helping youths in the region. He became a licensed foster parent and has cared for multiple youths over the previous years by opening his home. As of 2022, he's currently in the process



to adopt four children and is awaiting court proceedings. James has a personal mission to be the human he needed when he was a youth.

James is deeply rooted to civic organizations which include Young Professionals of Waterbury Region, Exchange Club of Waterbury, Building Equitable Opportunity Committee for Connecticut Community Foundation, Credit Union League of Connecticut, and more. He's previously served

on the boards for Main Street Waterbury, Habitat for Humanity of Greater Waterbury, Finance and Audit Review Commission in Waterbury, and Ambassador for the Waterbury Regional Chamber. His community involvement exemplifies his core values of commitment, leadership, and integrity. James received the 2017 Volunteer of the Year award at the 23rd Annual Malcolm Baldrige Chamber Awards.

James currently serves as the President and CEO of Skyline Financial Federal Credit Union in Waterbury, CT. In 2021, he was appointed President and CEO by the board of directors, James entered the position as the youngest CEO in the State of Connecticut for financial Institutions at age 33. He's successfully driven 20 years' worth of infrastructure upgrades and progression at the credit union within six months by virtualizing most of the operations, adding new technology to support today's banking needs, negotiating contracts for

reduced expenses, and increasing the support members needed. James received the 2020 Outstanding Credit Union Young Professional Award by the Credit Union League of Connecticut. James previously worked for FD Community Federal Credit Union as the Chief Operating Officer, Webster Bank as a Vice President, Fiserv as a Business Consultant, Indeed as an Account Executive and 3PL Worldwide as the Operations Director. James graduated from Albertus Magnus College with a Bachelor of Science with cum laude, in Business in 2013, and a Master of Administration in Business and Leadership in 2016. James received the Who's Who Among Students in American Universities and College's in 2016.
